

## NOTICE INVITING BIDS

**RECEIPT OF BIDS:** Sealed Bids from contractors will be received at the office of PARK CITY MUNICIPAL CORPORATION PUBLIC WORKS DEPARTMENT, OWNER of the WORK, located at 1053 Iron Horse Drive, Park City, Utah 84060, until 3:00 pm, on Thursday December 19, 2013, for construction of the QUINNS FIELDS IRRIGATION FILTER STATION project. Any Bids received after the specified time will not be considered. Proposals lacking required information will not be considered. All submittals shall be public record in accordance with the government records regulation ("GRAMA") unless otherwise designated by the applicant pursuant to UCA 63G-2-309, as amended.

**OBTAINING CONTRACT DOCUMENTS:** The Contract Documents are entitled QUINNS FIELDS IRRIGATION FILTER STATION. All Contract Documents will be available for download in electronic PDF format beginning Thursday December 5, 2013, at no cost (including specifications and half size drawings). Adobe Software will be needed to view the documents. To obtain bidding documents contact Chay Ryan at chaym@horrocks.com or by phone at 801-763-5100. Instructions on how to download will be provided. A hard copy will be available for viewing at Park City Municipal Public Works.

**DESCRIPTION AND SITE OF WORK:** For the project known as the QUINNS FIELDS IRRIGATION FILTER STATION, (hereinafter "Project"), the Work generally consists of construction of a raw water irrigation filter station and irrigation system connections with associated appurtenances. The work is located in Park City, Utah, as indicated on the Drawings.

The project includes the construction of a 750 gpm automatic self-cleaning filter station and pressure reducing valve in a buried concrete vault, raw water line connection, 4" & 6" irrigation supply lines, connections to existing irrigation systems, associated electrical, and site restoration.

**COMPLETION OF WORK:** All work shall be substantially completed by May 15, 2014 and final project completion by June 1, 2014. Time is of the essence.

**OPENING OF BIDS:** The Bids will publicly opened and read at 3:00 pm on Thursday, December 19, 2013, at the above-mentioned office of the OWNER.

**BID SECURITY:** Each Bid shall be accompanied by a certified or cashier's check, or bid bond in the amount of five percent (5%) of the total bid price payable to PARK CITY MUNICIPAL CORPORATION as a guarantee that the Bidder, if his Bid is accepted, will promptly execute the contract, provide evidence of insurance, and furnish a satisfactory faithful performance bond in the amount of 100 percent of the total bid price and a payment bond in the amount of 100 percent of the total bid price.

**ADDRESS AND MARKING OF BID:** The envelope enclosing the Bid shall be sealed and addressed to the PARK CITY MUNICIPAL CORPORATION. The envelope shall be plainly marked in the upper left-hand corner with the name and address of the Bidder and shall

bear the words "Bid for," followed by the title of the Contract Documents for the WORK and the date and hour of opening of Bids. The certified or cashier's check, or Bidder's bond shall be enclosed in the same envelope with the Bid.

**PROJECT ADMINISTRATION:** All questions relative to this project prior to the opening of Bids shall be directed to the ENGINEER for the project.
