DESCRIPTION AND SITE OF WORK: For the project known as the TOP OF MAIN PRV REPLACEMENT PROJECT, (hereinafter "Project"), the Work generally consists of a new precast concrete pressure reducing valve (PRV) vault, mechanical piping, valves, and electrical appurtenances, connecting to existing 10-inch and 12-inch waterlines, isolation valves, a water service line, fire hydrant replacement, removal and abandonment of an existing PRV vault, site and pavement restoration, and other associated work. All work is located within the City's Soil Ordinance Boundary near the intersection of Hillside Avenue and Main Street in Park City, UT.
