

NOTICE INVITING BIDS

RECEIPT OF BIDS: Sealed Bids from contractors will be received at the office of PARK CITY MUNICIPAL CORPORATION PUBLIC WORKS DEPARTMENT, OWNER of the WORK, located at 1053 Iron Horse Drive, Park City, Utah 84060, until 3:00 pm, on Wednesday, June 25, 2014, for construction of the ESTATES DRIVE WATER LINE REPLACEMENT PROJECT. Any Bids received after the specified time will not be considered. Proposals lacking required information will not be considered. All submittals shall be public record in accordance with the government records regulation ("GRAMA") unless otherwise designated by the applicant pursuant to UCA 63G-2-309, as amended.

OBTAINING CONTRACT DOCUMENTS: The Contract Documents are entitled ESTATES DRIVE WATER LINE REPLACEMENT PROJECT. All Contract Documents will be available for download in electronic PDF format beginning Wednesday, June 4, 2014, at no cost (including specifications and half size drawings). Adobe Software will be needed to view the documents. To obtain bidding documents contact Steve Jackson at steve@jackson-engineering.com or by phone at 801-558-5293. Instructions on how to download will be provided. A hard copy will be available for viewing at Park City Municipal Public Works.

DESCRIPTION AND SITE OF WORK: For the project known as the ESTATES DRIVE WATER LINE REPLACEMENT PROJECT, (hereinafter "Project"), the Work generally consists of construction of roadway modifications, potable waterline, and irrigation waterlines with associated appurtenances. The work is located in Park City, UT, as indicated on the Drawings.

The project includes the construction of approximately 1500 lf of PVC C900 potable water line, with appurtenances, connections to existing water services, cathodic protection, and asphalt restoration.

COMPLETION OF WORK: All work within Estates Drive shall be completed by October 15, 2014, and final project completion by November 1, 2014. Time is of the essence.

OPENING OF BIDS: The Bids will publicly opened and read at 3:00 pm on Wednesday, June 25, 2014, at the above-mentioned office of the OWNER.

BID SECURITY: Each Bid shall be accompanied by a certified or cashier's check, or bid bond in the amount of five percent (5%) of the total bid price payable to PARK CITY MUNICIPAL CORPORATION as a guarantee that the Bidder, if his Bid is accepted, will promptly execute the contract, provide evidence of insurance, and furnish a satisfactory faithful performance bond in the amount of 100 percent of the total bid price and a payment bond in the amount of 100 percent of the total bid price.

ADDRESS AND MARKING OF BID: The envelope enclosing the Bid shall be sealed and addressed to the PARK CITY MUNICIPAL CORPORATION. The envelope shall be plainly marked in the upper left-hand corner with the name and address of the Bidder and shall

bear the words "Bid for," followed by the title of the Contract Documents for the WORK and the date and hour of opening of Bids. The certified or cashier's check, or Bidder's bond shall be enclosed in the same envelope with the Bid.

PROJECT ADMINISTRATION: All questions relative to this project prior to the opening of Bids shall be directed to the ENGINEER for the project.
