ADDENDUM No. 1

The following modifications and clarifications are hereby made to the Request for Qualifications for the JSSD-PCMC Interconnection Improvements – Engineering Services issued October 24, 2016:

Modifications:

1. Remove the following from Section 4.4:

SECTION II - TEAM ORGANIZATION AND QUALIFICATIONS & COST ESTIMATE

Four (4) Page Limit. Provide the following information about the project team participating in the Project.

1. Project Organization & Staffing. Provide an organization chart for this project. Identify only key persons for the project team assigned to this work. Identify the key personnel proposed to perform the work on the project, and indicate major areas of subconsulted or subcontracted work, if any.
2. Key Personnel. Provide a list of key personnel who have specialized experience and expertise relating to the consulting services criteria. List only those that are likely to actually perform the work described in this RFQ (NOTE: Do not include percentages of availability as this may be misinterpreted). List the location of the office to which each is assigned. Provide resumes for key personnel in an Appendix, not to exceed four total pages, that indicates their education, registrations, and expertise relative to the work defined in this RFQ.
3. Roles. Provide a brief narrative of what each key personnel will contribute to the project, their special expertise, and how they will enhance the project deliverables.
4. Project Manager. A strong project manager experienced in the management of technical multi-task projects and focused on the delivery of the project to the City is important to the City. Qualifications representing staffing and experience of such an individual may be awarded a higher scoring.
5. ~~Cost Estimate. Provide an estimate of total project costs given the information presented herein, including engineering services both as a cost and as a percentage of the total project cost.~~

2. Add the following to Section 4.4:

SECTION III – SPECIFIC – EXPERIENCE, REFERENCES & COST ESTIMATE

Five (5) Page Limit. The intent of this section of the proposal is to establish the ability of the Proposer's team members to provide the services specific to tasks identified in the Project. Proposal content should provide obtain information about similar projects the proposer and the project manager have completed within the past 5 years that will illustrate the team's ability to perform services required for this project. The projects referenced should be directly related to water pumping and transmission facilities and should be directly associated with the key personnel identified in Section II. As a minimum, address the following key Project related items:

1. Provide qualifications, experience, certifications, and Proposer party(s) responsible for the evaluation, design, installation and other services associated with water pumping and transmission facilities.
2. Provide a listing or table summarizing water pumping and transmission evaluations and/or designs completed by your proposed team members in the last five years that are applicable to the stated Project objectives.
3. Identify experience specific to welded steel pipelines and cathodic protection systems.
4. Identify experience specific to PVC, ductile iron, or HDPE pipelines
5. Identify experience specific to electrical, controls and SCADA system design, specifically Allen Bradley PLCs and Inductive Automation's Ignition SCADA platform.
6. Provide at least three (3) client references of similar projects. Include phone and email contact information.
7. Provide an estimate of total project costs given the information presented herein, including engineering services both as a cost and as a percentage of the total project cost.
