

What is a Stay at Home Order?

In an effort to slow the spread of COVID-19, Summit County residents are being asked to stay at home and avoid travel, with the exception of going to grocery stores, convenience stores and pharmacies for essential items such as food and medication. Residents may also leave their homes to attend necessary or urgent medical appointments, pick up material to work at home; and to care for family members or pets. We ask that people practice social distancing while doing any of these essential activities.

When is the timeframe for the Stay at Home Order?

The Order goes into effect Friday, March 27 at 12:01 a.m. and will last until at least May 1, but will be reviewed after 14 days. At that point, the Order could be ended, extended or modified.

What businesses are approved to remain open?

Essential business and government services will remain open, and essential infrastructure projects will continue. **SEE BELOW** for a detailed list of businesses that are considered essential. If you have a question about a type of business not listed below, please call 435.333.0050.

Will State liquor stores remain open?

State liquor stores will continue operating from noon to 7 p.m. Monday through Saturday.

Is Park City Transit still operating?

Yes, however people must use public transit only for purposes of performing Essential Activities or to travel to and from work for the purpose of working at an Essential Business, or to maintaining Essential Governmental Functions. Passengers on public transit must follow social distancing requirements.

Can I still go outside and exercise?

Yes, walking, hiking, running, biking, etc. is permitted, but please practice social distancing on trails or while visiting outdoor recreation areas. Congregation in groups is not allowed anywhere in the county including outdoor spaces such as neighborhoods, parks and trails.

Can I meet up with a small group of friends? No, all public and private gatherings of any number of people are prohibited. The order does not apply to people sharing a household.

What is Social Distancing? Social Distancing means maintaining at least six-foot social distancing from other individuals, washing hands with soap and water for at least twenty seconds as frequently as possible or using hand sanitizer, covering coughs or sneezes (into the sleeve or elbow, not hands), regularly cleaning high-touch surfaces, and not shaking hands.

How does this Order apply to non-resident homeowners? Non-resident/second homeowners are strongly encouraged to leave or not travel to Summit County.

What about Visitors already in Summit County?

Visitors to Summit County are directed to return home immediately, but no later than April 1, and persons considering visiting Summit County should remain home.

"Stay At Home" Public Health Order Rumors

Sheriff Justin Martinez wants to address rumors that are going around the community:

- There will be police checkpoints FALSE!

- I can go outside for walks/run, hikes, bike rides TRUTH! We want you to stay healthy! Just practice physical/social distancing while doing so. If a trailhead is full, find another one.
- If I do not live in Summit County, I SHOULD NOT go to Summit County to recreate TRUTH! Please recreate in your own city/county until orders are lifted. Thank you!
