Exterior Walls: Walls are clad in wood drop siding and corner boards. The front partial-width porch is supported by simple square columns with shed extensions out to the sides, making it a full width porch. The rail is a simple inverted king-post truss design Foundation: Concrete

NARRATIVE DESCRIPTION OF PROPERTY

The house at 335 Woodside Avenue is under construction in the most recent images, with the house being raised and the site excavated to build a basement level addition. A large rear addition is also being built. The main house has been stripped to its framing and has had new OSB sheathing installed. The 1984 National Register nomination follows:

"This house is a one story frame hall and parlor house with a gable roof. Typical of the hall and parlor house is the rectangular form, the symmetrical facade with a door centered between two windows, and the porch spanning the

facade. The piers that support the section of porch between the windows may be original, but the porch roof, the side piers, and the balustrade were later additions. Those changes are unobtrusive and are reversible. The roof of this house slopes off to the rear, resembling a saltbox roof. An original shed extension such as this was common in Park City houses, allowing the two room hall and parlor form to be expanded to a four room house. There is a door with a small balcony set in the top half story of the south gable end. All of the original windows are the one over one double hung sash type. Two small windows in the north wall are more recent additions, but the change is minor. Despite the minor porch and window changes, the house maintains its original character."

The house was renovated and added to from 2013-15. The west (rear) addition is a simple one-and-a-half story gable-roofed structure. It is clad in salvaged wood and features double-hung sash type windows. The roof appears to be standing-seam metal. The historic house was reclad in drop wood siding, which be the original materials photographed in 1983. Removing historic cladding as panels and reinstalling onto a modern insulated wall is common practice in Park City and was used on this house. New windows were installed in the historic segment, as well, and these also mimic the historic double-hung sash type used in most early twentieth century Park City houses. Although the overall form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

This house was built between 1889 and 1900, and it is unclear if it was built while the property was under the ownership of the Park City Townsite Corporation, or by William Tretheway, who purchased the property from the company in 1893. William was a mining foreman who emigrated from England in 1883. He lived at the house with his wife Jessie, and their two children. They sold the property in 1901 to Lizzie Campbell.

No record of Lizzie and her husband William living at the house exists, though there is a note of them living on Heber Avenue in the 1900 census. The ownership of the house was transferred to the county in a tax sale in 1912. Fannie B. Watterson purchased it from the county in 1927.

Fannie B Watterson did not live at the property during the 1930 or 1940 censuses. Donald Eddington, his wife Elsie, and their family rented the home in 1930. Donald was born in Idaho and was a carpenter for a mine, and his wife was born in Utah. The house was rented by George Jennings and his wife Mary during the 1940 census. George was a truck driver, and he and his wife had lived at that house since at least 1935, as noted on the census. Fannie Watterson sold the property to Rex Leatham in 1944.

There were two men named Rex A Leatham in Park City at this time, but it is unknown which of them purchased the house. The house has traded hands many more time since the historic period, and is currently owned by John K Watkins, and Erich W Joiner.




