NARRATIVE DESCRIPTION OF PROPERTY

The house at 1007 Woodside does not resemble any of the common house types built during the historic mining era, possibly due to the fact that the house was built late during the mining decline, c. 1955. The house has been significantly added to. A cross-wing addition was added to the original rectangular block house seen in the c. 1940 tax photo. A lower garage addition was also built at the street and a projecting bay built on the primary façade of the house. The cross gable roof is truncated on the cross-wing section and is sheathed with standing seam metal. The walls are clad with wood or composite siding, with fish scale wood shingles in the gable of the projecting bay. The windows have been altered; every window shown on the primary façade in the early tax photo has been replaced or changed. There is a sliding window in the upper gable and another sliding window in the projecting bay next to the door. Another window may be present on

the front façade, but it is obscured in available images and cannot be determined. The door is wood with an ornate leaded glass upper light. A deck area has been created on the roof of the garage addition and a simple wood balustrade surrounds it. A concrete block retaining wall runs along the sidewalk until it meets the stairs that leads to the porch and deck area. Although the form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:
(Briefly describe those characteristics by which this property may be considered historically significant.)

Though there was a house present at this address in the 1889 Sanborn map, the 1900 Sanborn map shows a house that is so different that it is likely the original house was demolished and a new house built in its place. The forms shown on the Sanborn map do not closely match the c. 1940 tax photo available, even though they are supposedly just a few years apart. It is possible that the house shown on the Sanborn maps was demolished and a new house was built, but this is just speculation.

The house that is shown on the 1900 Sanborn map was built while the property was under the ownership of either the Park City Townsite Corporation, A.W. Webster, or Patrick and Ellen Nolan. No information could be found on A.W. Webster or Patrick and Ellen Nolan. The property came back under the ownership of the Park City Townsite Corporation by 1899 when it was sold to Edith T. Geigor.

Edith appears on the 1900 census living in a different house in Park City, on Norfolk Avenue. She lived there with her husband John, and her nephew. John worked as a bookkeeper. They sold the house to Francis Shields in 1906.

Francis Shields appears on the 1900 census living somewhere on Woodside Avenue, but exactly which house is unknown as addresses were not given on that year's census for this area. He was living with his family at that time, and going to school. No other information is available on him. The house was unoccupied during the 1910 and 1920 censuses, and was sold to Clyde Peter Paul in 1925. Clyde Paul was a carpenter and builder in the area, and was involved on many buildings in the town. He lived in Park City with his wife Blanche and their son Bruce during the 1930 census, though this house had come under the ownership of the county by 1928.

The next owner was Lilia Tretheway. Lillia Tretheway was an English immigrant who came to the U.S. in 1907. She worked in Park City as a dressmaker. It appears that she rented out the house, because during the 1930 census the house was occupied by Vern and Anne Brunyer. Vern worked as a laborer for a mine, but nothing else is known of them.

The house was not occupied during the 1940 census, and was sold by Lilia Tretheway in 1949. It has had a few owners since that time, and is currently owned by Cheryl Soshnik.





Figure 1: Aerial view showing the location of 1007 Woodside Avenue. (ESRI 2020)


