#### NARRATIVE DESCRIPTION OF PROPERTY

This is a modified hall-parlor type house that was added on to the northwest during the historic period. The metal-clad gable roof has been expanded upwards on the western aspect with the northwest addition. The front façade faces east (away from Anchor Avenue) and is comprised of a central entrance flanked symmetrically by two double-hung windows. The porch originally covered this entrance exclusively but has been extended to the north side of the house, where a glazed door was added at a later date. Most of the windows are double-hung, with a triple casement window on the front most façade. The house is clad in drop-novelty wood siding, with subtle Victorian-style trim around windows and doors, typical of historic Park City residences. There are two metal chimney flues protruding from the roof, one near the center of the original house and one in the western addition.

The house was disassembled and reassembled ("panelized") as part of a larger renovation and construction of a new addition in 2015-2017

Narrative Statement of Significance:

Photographic and Sanborn Map evidence indicated that this house was built at some point in the 1880s, making it one of the oldest and most historically valuable houses in Park City, as it has been altered or added to minimally over the decades. The title history of the property makes it difficult to determine who exactly built the house; the Townsite Company (represented by Edward and W. Mont. Ferry, then David McLaughlin and W.I. Snyder) owned the property until 1916, when it was sold to D.L.H.D. Grover, a Chinese immigrant who owned over seventy-five houses in Park City at the time of his death in the 1930s. In other words, the property was owned by a series of individuals with corporate interests for most of its history, making it difficult to determine who the early residents were.

The house was built before the 1889 Sanborn as a simple hall-parlor dwelling with a front porch on the east façade. By 1900, the west volume was extended to the north, a footprint that was maintained in the 1907 Sanborn. The 1929 Sanborn shows a house that was largely unchanged; the name "McDonough" is penciled onto the map, indicating a likely resident at that time. The 1941 Sanborn shows a similar footprint, with an outbuilding sketched to the northeast of the main house. The porch was wrapped around to the north and the roof was expanded by the time an early 1940s tax photo was taken of the property. Any major alterations or additions were done by the time of the 1940s tax photo, and the house remains very similar to its historic appearance and integrity. The house underwent reconstruction in 2015-2016.








