NARRATIVE DESCRIPTION OF PROPERTY

(Briefly describe the property and its setting. 1160 Park is a pyramid house that had an addition built to its rear between 2006 and 2008. The pyramid house is one of the main three house types built during the historic Park City mining era, and is the most recent of the three, occurring mostly at the end of that time period. The complex roof is sheathed with patterned asphalt tile and has an 18" metal edging at the edge of the roof. A small gable roof projects off the main roof to cover the porch area. The house is clad with drop-novelty wood siding with board-and-batten siding on some parts of the addition. The new front façade windows with three narrow panes, are placed on either side of the door, and are similar to what is seen in the early tax photo. The door is wood, with a large upper light. The porch roof is supported by large square wood columns. The lot is almost entirely taken up by the house with only a small yard at the front. The yard is

enclosed by a metal fence. Although the addition is visible, the original pyramid house remains legible. Although the form remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

(Briefly describe those characteristics by which this property may be considered historically significant.)

Though a structure does appear on the 1929 and 1941 Sanborn Insurance maps, it more resembles a shotgun type house than the pyramid house shown in the early tax photos. It seems likely that this house was either built in the 1940's, or moved from another location at that time. Since this was after the 1940 census, it is unknown who exactly lived in this house, but the title history shows that the house was likely owned by Herbert Heckt.

Herbert Heckt appears on the 1940 census, living in a house on Woodside Avenue with his wife Beryl and their son. He was a mining engineer with the Silver King mining company. They moved to Denver in 1945, and the house was purchased by John Cone, who was an engineer for the New Park mine. The house has been bought and sold many times since the historic period, and is currently owned by Joel and Sandra Stokes.












1160 Park Avenue, Park City, Summit County, Utah Intensive Level Survey—Sanborn Map history
