What is Domestic Violence

Domestic Violence is a pattern of behaviors used by one person over another to gain or maintain power and control over another person in a familial or intimate relationship. This can include physical, emotional, verbal, sexual, financial, and digital abuse. It can also involve controlling behaviors, such as isolating them from friends and family, monitoring their movements, and limiting their access to resources.

Jail Release Agreement (JRA)

UT Code 78B-7-802

A person arrested or issued a citation for domestic violence must either sign a JRA or they will be issued a Jail Release Court Order.

Common conditions within a JRA:

- No contact with the victim
- No threatening or harassing the victim.
- Cannot knowingly enter the premises of the victim's residence or any premises temporarily occupied by the victim.
- Victims are able to request that the No Contact Order be extended for 72 hours or waived. Waiver request must be made in writing and submitted to the court.
- No third-party contact

What Is An IPV Exam?

Anytime an individual is physically assaulted or strangled, it is recommended that the individual be medically evaluated in an emergency department. A forensic nurse will respond to the hospital to provide medical care and perform an Interpersonal Violence (IPV) exam.

What an Interpersonal Violence (IPV) Exam includes:

- A medical evaluation and history of the assault
- Physical assessment and photo documentation of injuries
- Collection of forensic evidence
- If strangled, possible imaging recommended.
- Coordination with the emergency department regarding patient care and follow-up
- No cost to the patient
